INTRODUCTION

Welcome to BlueIT. We use cookies and similar technologies on our website to improve your experience, analyse our services, and provide personalized content and ads. This cookie policy explains what cookies are, how we use them, and what choices you have regarding cookies.

POLICY

PURPOSE

Provide transparency to users about the use of cookies and similar technologies on a website. Specifically, our cookie policy has the following purposes:

- “ **Inform:** To make it clear to users what cookies are, what types of cookies are used, and why they are used.
- “ **Obtaining consent:** Informing users on how to give their consent to the use of cookies and how to manage their cookie settings.
- “ **Protect:** Reassure users that their privacy is respected and that cookies are used responsibly.
- “ **Compliance:** Comply with legal requirements and regulations, such as the General Data Protection Regulation (GDPR) and the EU ePrivacy Directive.

SCOPE

The scope of a cookie policy covers all aspects of the use of cookies and similar technologies on our website.

Specifically, the scope includes:

- “ **Types of cookies:** Explanation of the different types of cookies used, such as functional cookies, analytical cookies, and marketing cookies.
- “ **Purposes of cookies:** Why the cookies are used, for example to make the website function, to analyze user behavior, or to show personalized advertisements.
- “ **Storage duration:** How long the cookies are stored on the user's device.

- “ **Managing Cookies:** Information about how users can manage their cookie settings, including how to accept, reject, or delete cookies.
- “ **Data sharing:** Whether and how the information collected by cookies is shared with third parties.
- “ **Consent:** How users' consent is obtained and recorded for the use of cookies.

WHAT ARE COOKIES?

Cookies are small text files that can be stored on the computer when visiting websites. This text file stores information such as your language preference for a website. When you visit the website again later, this cookie will be sent to the website again. In this way, the website recognizes your browser and can, for example, remember your language preference.

Cookies also usually have an expiration period. For example, some cookies are automatically deleted when you close your browser (the so-called session cookie), while others remain on the computer for a longer period of time, sometimes even until you delete them manually (the so-called persistent cookie).

WHY DO WE USE COOKIES?

BlueIT uses cookies and similar technologies to distinguish your user preferences from those of other users of our website. This helps us to provide you with a better user experience when you visit our website. It also allows us to optimize our website.

YOU PERMISSION

When you first visit our website, you will be asked to accept our cookies. By pressing 'OK' you accept all cookies used by us.

You can decide for yourself which cookies you accept via 'cookie settings'. The explanation of the cookies we use can be found below. You accept the cookies by clicking on the checkmark.

You can also refuse or block cookies by changing the configuration parameters of your navigation system.

Not accepting cookies may mean that you cannot use certain functionalities of the website.

TYPES OF COOKIES AND THEIR RETENTION PERIODS

Although there are different types of cookies, which differ in terms of functionality, origin or retention period, the legislation necessarily distinguishes between functional or technically necessary cookies on the one hand and all other cookies on the other.

BlueIT uses the following cookies:
